Minutes

The University of Virginia's College at Wise Board

February 2, 2024

The University of Virginia's College at Wise Board met in-person and virtual on Friday, February 2, 2024 at 9:00 a.m. Members present were Mike Allen, Jimmy Adkins, Brian Blanton, Phillip Blevins, Jonette Dixon Carpenter, Valeri Colyer, Kathy Curtis, Marcia Gilliam, Marvin Gilliam, Don Green, Leton Harding, George E. Hunnicutt, Jr, Charlotte Mabry, Duane Miller, Karen Mullins, Rhonda Perkins and Ruby Rogers. UVA Vice President of Communications and Marketing, Dave Martel was in attendance. Members absent were Scott Litton and Robby Stallard.

Chair Marcia Gilliam presided over the meeting and Dawn Jessee recorded minutes. Chancellor Donna Henry opened the meeting by leading everyone in the Pledge of Allegiance.

A motion was made by Rhonda Perkins and seconded by Lewey Lee to approve the agenda as presented. The motion received unanimous approval.

A motion was made by Mike Allen and seconded by George Hunnicutt to approve the minutes of the November 3, 2023 meeting of the College Board as presented. The motion received unanimous approval.

Remarks by Chair: Chair Gilliam welcomed everyone to the first meeting of 2024. She shared a few news articles including the announcement of new head football coach, Gary Bass, successful highlights of alumna Annie Jordan's business as a wedding planner, Don Green's receipt of the Virginia Governors' Volunteerism and Community Service Award, UVA's Cavalier Daily reporting of UVA Wise's most recent accomplishments regarding increased fall enrollment and goal of reducing out of state tuition. Please check pages 20 and 21 of the board packets regarding upcoming events and important dates.

Remarks by Vice Chair: Mr. Lewey Lee reviewed the College's major milestones through the past seventy years to emphasis how much the College has grown and accomplished since its beginning.

Remarks by Alumni Association Board Member: Mr. Jimmy Adkins reported that the Board of Directors met on November 14 and the next meeting will be virtual and is scheduled for February 13. The Alumni Association held an event on December 7 at Ax & Ale House in Bristol, owned by fellow alum L. J. Boothe, Class of 2007. Upcoming alumni events are scheduled for Buchanan County in February, Knoxville in early March, Charlotte in late March, Richmond/Roanoke in early May, NOVA in late May and Tidewater in July. The Alumni Association's two major events -- the Community Spring Swing golf tournament sponsored by Ballad is scheduled for April 19 and the 37th Cavalier Celebration Gala on May 18 at the Inn at Wise. Tickets are \$125 each and admit two people to the

event. The Highland Cavalier Red & Gray Game is scheduled for April 27 and Homecoming is scheduled for the week of October 12.

Remarks by Student Member Charlotte Mabry. Student member Mabry reported the following: The Office of Student Engagement hosted an event on January 22 for students to personalize toboggan hats, the Office of Student Recreation in collaboration with Student Engagement hosted free bowling and free pizza at Hillcrest Lanes. Free transportation was provided by MetGo with over 80 students attending. An indoor hockey tournament and dodge ball tournament was held and they are currently preparing for the intramural basketball season. Students from Walk to Campus reported safety concerns regarding the walk way around the baseball field due to the construction. Thanks to Julie Scott and John Carter, the issue was resolved. One of the Canterbury study abroad students, Zariah Scales, shared that her recent trip was "honestly" the best time of their life. She made life-long new friends and had a once in a lifetime experience. She plans to attend Duke to pursue a doctorate in physical therapy. A big thank you to UVA Wise for providing this opportunity to students. Another stand out student, Logan Smith was accepted into VCU dental school. Ms. Mabry also announced that she would be attending Emory & Henry in the fall to obtain a doctorate in occupational therapy.

Chair Gilliam recognized and welcomed Dave Martel, UVA Vice President of Communications & Marking to the board meeting.

ACTION ITEMS

Center for Teaching Excellence Tuition Reduction: The University of Virginia's College at Wise Center for Teaching Excellence provides undergraduate-level courses that meet the needs of teachers with 1) a provisional teaching license who are seeking full licensure and 2) those with full teaching licenses seeking recertification. The College presented tuition and fee rates for two academic years consistent with the University of Virginia's strategy for undergraduate tuition and fees to the College Board in November 2023, and the Board of Visitors in December 2023. In order for the Center for Teaching Excellence to remain competitive with local and regional providers who have created similar programs as well as online programs, the College recommends to reduce the cost of licensure courses from \$224 to \$199 and the recertification courses from \$133 to \$116. A motion was made by Phillip Blevins and seconded by George Hunnicutt to approve the reduction in cost per credit hour for K-12 Educators Licensure and Recertification as proposed. The motion received unanimous approval.

CLOSED SESSION

As required by the Code of Virginia Section 2.2-3712 (a) and 2.2-3711(A)(9), a motion was made by Mike Allen and seconded by Lewey Lee to convene in closed session for the purpose of discussing a proposed gift to the College and related naming opportunity.

RECONVENE IN SESSION

As required by the Code of Virginia Section 2.2-3712(d), a roll call vote was taken in open session noting only public business matters lawfully exempted from open meeting requirements and only public business as identified in the motion by which the closed session was convened were heard, discussed, or considered in the meeting of the public body. A motion was made to name the court in the David J. Prior Convocation Center the Quillen Court by Mike Allen and seconded by Rhonda Perkins. The motion received unanimous approval.

Report Items:

BOV Faculty Consulting Member Report: Jinny Turman, Professor of Public History and Co-Director of Center for Appalachian Studies provided updates regarding the good work being done by UVA Wise faculty and students. Her report included the following; Associate Professor of Biology Josephine Rodriguez secured a major grant from the National Science Foundation in the amount of \$100,000 to explore strategies for STEM education that will help students overcome socio-economic barriers that limit their advancement into STEM fields. This award then led to the application of another larger multi-state and multi-institutional S-STEM proposal called PACE (Pathways to Access, Collaboration, and Equity for Central Appalachian Students). Associate Professor of Information System, Karen Carter assumed the role of Principal Investigator for these grants upon Professor Rodriguez appointment as Program Director for the Division of Undergraduate Education at the National Science Foundation. From the Visual and Performing Arts Department Adjunct Strings instructor Dave Eggar was nominated for two Grammy Awards, Professor of Music Hannah Ryan presented at the Kentucky Music Educator's Association, served as guest clinician at the All-District 7 Choir and revived a children's choir at UVA Wise for Wise County students under the mentorship of UVA -Wise music majors; Associate Professor of Music Donald Sorah produced multiple compositions that were performed by different ensembles, served as the guest clinician for the Sullivan County Junior All-County Band and was the recipient of the Apple Distinguished Educator Award for his course, Everyone Can Create Music, which introduces acoustics, fundamental of music and digital audio and recording techniques using an iPad. He was one of 58 recipients nationwide and the only recipient in the state of Virginia and the first faculty recipient at UVA Wise. Additional faculty recognitions include Associate Professor of Biology Walter Smith mentored students in an international survey of pathogens affecting amphibian populations that tracks the spread of two different fungal pathogens threatening to kill off massive numbers of amphibians. Associate Professor of Physical Education Cody Sanders is in year three of a collaborative grant funded program that pairs student with UVA's Cancer Center, Cancer Center Without Walls Regional Advisory Board and Coeburn Middle School in Wise County to promote Fam Health designed to break the generational cycle of dependency on tobacco. Student and Faculty publications include Professor of Biology Bruce Cahoon who co-authored a study with several of his students including Lucie Hornberger a Year in Wise student and current UVA student that involved an assessment of how species evolve which focused on a type of micro-algae organism that resides in freshwater ponds in this region. Another UVA Wise student and Goldwater scholarship winner Isabella Maggard built on Ms. Hornberger's research by completing a metagenomic analysis of the organism which is of interest as an evolutionary relic such as a living fossil whose lineage is not linked to any other extant life on Earth, i.e. its lineage is ancient and unique. These genomes are now archived in GenBank which links UVA Wise and our regional for anyone else around the world studying microbes. Professor of Communication and Appalachian Studies Amy Clark and Associate Professor of Biology Ryan Huish, UVA Faculty, UVA and UVA Wise students qualitative project to study the vernacular names used in Appalachia for medicinal plants and dermatological conditions with a goal to provide a database that will improve cultural competency for providers.

<u>Strategic Plan Update:</u> Chancellor Henry provided a strategic plan update that included the celebrations of the College's receipt of the Innovation and Economic Prosperity (IEP) Designation and successful Reimagination of the Liberal Arts Core. Attached is the report outlining updates.

Virginia Legislative Updates: Vice Chancellor for Administration, Government Relations & Strategic Initiatives Shannon Blevins shared that the 2024 Legislative Session convened on January 10th with 51 new representatives (17 in the Senate and 34 in the House). UVA Wise participated in the Virginia Business Higher Education Council's New Member Meet and Greet in Richmond on January 8. Meetings are being held with the higher education and money committees and with our regional legislators who are incredibly supportive of the College. There was very good representation at the SWVA legislative reception held on January 31. Crossover is scheduled for February 13 with chamber releasing budgets on February 18. The next meeting with legislators is February 20. The UVA and UVA Wise Legislative reception is scheduled for February 19 with a group of students from UVA Wise attending. Legislative Session is scheduled to end on March 9.

<u>Chancellor's Report:</u> Chancellor Henry shared that several members of the UVA Board of Visitors will be making a trip to SWVA on April 10 and 11. They will be staying in Abingdon at the Martha Washington Inn for a reception hosted by BOV member Amanda Pillion at her home on the evening of April 10. On April 11, the group will be transported to UVA Wise campus for an official Committee on Wise meeting and attend the rededication of the Pippin-Wyllie Hall. As a member of the NCAA DII Presidents Council, Chancellor Henry attended the NCAA Annual meeting in January. At this meeting, UVA Wise was recognized as an institution for community engagement. Out of 33 recipients, UVA Wise ranked 3rd and received a cash prize.

The next meeting will be May 10,2024.

ACTION ITEMS

Promotion and Tenure: Each year certain faculty members undergo the process for promotion and tenure. Faculty rank and promotion are based on criteria adopted by the College Board and listed in the Faculty Handbook. These criteria include academic qualifications, years of experience, and demonstrated achievement in the areas of teaching, service and scholarship. The faculty member submits a portfolio which is reviewed by the academic department, the department chair, and the Faculty Committee on Evaluation. The Faculty Committee on Evaluation reviews all portfolios and submits their recommendations to the Academic Dean and Provost, who also make recommendations. The final approval at the College lies with the Chancellor prior to being submitted to the College Board for review and the Board of Visitors for approval. Interim Provost Mark Clark presented faculty promotion candidates.

A motion was made by Karen Mullins and seconded by Phillip Blevins to approve the resolution as presented. The motion received unanimous approval.

<u>UVA Wise Master of Technology Management & Data Analytics</u>: Business Department Chair and Professor Gurkan Akalin reported on the progress toward implementation of the UVA Wise Master of Technology Management & Data Analytics and reviewed the program announcement, including the workforce needs and duplication analyses, provided to the State Council of Higher Education for Virginia (SCHEV). Attached as Appendix A.

A motion was made by Brian Blanton and seconded by Jimmy Adkins to approve the Master of Technology Management & Data Analytics Program and support the program announcement, including the workforce needs and duplication analyses provided to SCHEV, effective August 2025. The motion received unanimous approval.

<u>UVA Wise Proposed Budget Fiscal Year 2024-2025</u>: Chancellor Henry and Associate Vice Chancellor for Finance and Operations, Joe Kiser, presented an overview of the 2024-2025 budget plan.

The budget for the 2024-2025 Fiscal Year has been prepared with instructions from the University's Budget Office and with participation from a number of campus constituencies. The budget process included the Chancellor, each Vice Chancellor, and an oversight group which included the Senior Leadership team, Chairman of the Faculty Senate Finance Committee, Chairman of the Staff Senate, and the Budget Office. The University's budget process requires that the various units and agencies of the University provide budgetary information by the end of January, so the

entire budget can be compiled for action by the College Board in May and the Board of Visitors at its June meeting.

The budget is based on acceptance of the tuition and E&G fee proposal approved by the College Board and the Board of Visitors in compliance with the College's Six Year Plan. The College Board approved no increase of in-state tuition and E&G fees at its November 3, 2023, meeting. These were approved by the Board of Visitors during its December 7-8, 2023, meeting. The budget factors in the other charges previously approved by the Board and BOV, state operational funding, and current enrollment projections. Given the current economic climate, the budget and its assumptions continue to remain fluid.

The proposed budget incorporates the assumptions based on the conference budget. The budget allocates resources to provide for a three percent pay increase, which is fund split for E&G positions between the Commonwealth and College, and the College funds the entire pay increase for auxiliary and sponsored program paid positions. The budget includes \$1M in additional operating support for the College which will be utilized to fund the College share of the pay increase.

The 2024-2025 operating budget for UVA Wise is projected to total \$75.6 million, an increase of 5.4 percent as compared to the original 2023-2024 budget. The budget is based on the Conference Report. This budget is subject to change upon the final budget as approved by the Governor. Per the Conference Report, the College received additional operating support in the amount of \$1,000,000 from the Commonwealth.

A motion was made by Brian Blanton and seconded by Phillip Blevins to approve the resolution as presented. The motion received unanimous approval.

<u>Election of the UVA Wise College Board Clerk</u>: As required by the bylaws, the University of Virginia's College at Wise Board, upon recommendation of the Chancellor, shall elect annually a member of the College to serve as Clerk of the Board. The Chancellor recommends that Paul Rollins be re-elected as Clerk of the Board.

Report Items:

Virginia Legislative Update: Chancellor Donna Henry and Shannon Blevins ...

A budget was approved on May 9 with the Governor expected to sign off on very soon. Shannon Blevins and Chancellor Henry have plans this summer to travel and meet with the education committee and the finance committee, new legislators, as well as local legislators to increase awareness of UVA Wise and the good work being done. The Governor is confirmed to be on campus on May 23 for the SWVA Economic Forum as the keynote speaker.

<u>UVA Wise Football Report presented by Head Football Coach Gary Bass</u>: Coach Gary Bass shared that he was very excited to be at UVA Wise and thankful for the support given to his family and the football program. His goal for the spring was to build relationships with the players in person, "how you do anything is how you do everything" motto and becoming involved in the College. The players need to be committed and involved. They participated in community engagement through

helping with local blood drive, providing a coaches' clinic for the public, by visiting Wise primary schools and the youth camp at the spring game that had over 500 participants. He indicated that it was great to meet alumni and community at the spring game and a gave a big thanks to the tailgate activities supported by Valerie Lawson's team. Culture development is extremely important and is accomplished by laying out clear cut standards and expectations with a work ethic emphasized. Player development involved hiring a full-time strength coach, which has been very beneficial. Current recruiting has targeted over forty high schools within 1.5 hours driving distance and the plan is to recruit in our own backyard. Twenty-three of the recent thirty players recruited are regionally located within a 2.5-hour radius of the College. Coach Bass will continue to advance the value of academics with a GPA goal of above 3.0 – which will be work in process. A team goal defines love as sacrifice. Football involves sacrifice, full-time involvement, and work. He plans to approach winning as process driven and not result oriented. Players need to understand how to compete first to win. Coach Bass indicated that everyone in the community has been incredibly supportive of him and the team.

Chancellor's Report: Chancellor Henry shared highlights of the enrollment report included in the board packets --applications are almost double compared to last year's with admitted numbers up by almost 50% and confirms are at 532 which is above last year's numbers. Transfer numbers are up as well. The Year in Wise target was 75 and the College is currently at 144 year in wise students indicating they are interested in attending UVA Wise. There are 49 international students confirmed with 15-20 expected to attend. Financial aid packaging is moving along. Current student enrollment is up 7% from this time last year (returning numbers). Full-time numbers are up as well. There are 14 graduate students graduating in 2024 and currently there are 10 full-time and 10 part-time registered for fall. Fall to Fall retention is tracking at 73% and we are hopeful those numbers will continue to come up. It is an exciting time to be at UVA Wise. A Director of International Program consultant has been engaged to review the needs of international students such as food preferences. In this regard, the College is researching the possibility of adding a community kitchen in Culbertson Hall to accommodate International Student needs at an approximate cost of \$150K. The new organizational structure includes Tabitha Smith as Interim Vice Chancellor of Student Affairs and Human Resources now reports to Paul Rollins, Vice Chancellor & Chief of Staff. Joe Kiser has replaced Chancellor Henry on the GO Virginia board. Costs are being reviewed for outdoor Wi-Fi and a Pickleball court near Greear Gym. Both will add to the campus environment for our students.

Tomorrow the Commencement Brunch will begin at 8:30 a.m. and the Champagne Toast is tonight at 8:00 p.m. by the Lake. Budget slides were not included in the board packets and will be sent to you after the meeting. The Symphony of the Mountains on the Lawn by the Lake is scheduled for July 20^{th} .

University of Virginia's College at Wise Board

August 23, 2024

The University of Virginia's College at Wise Board met in-person on Friday, August 23, 2024 at 9:00 a.m. Members present were Mike Allen, Brian Blanton, Phillip Blevins, Valeri Colyer, Marcia Gilliam, Marvin Gilliam, Cedric Green, Leton Harding, George Hunnicutt, Jr., Fran Hunt, Lewey Lee, Karen Mullins, Rhonda Perkins, Ruby Rogers, Jimmy Adkins, and Layne Bush. The members absent were M. J. Carpenter, Kathy Curtis, Don Green, Scott Litton, Duane Miller and Robby Stallard.

Chair Marcia Gilliam presided over the meeting and Dawn Jessee recorded the minutes. Chancellor Donna Henry opened the meeting by leading everyone in the Pledge of Allegiance.

A motion was made by Phillip Blevins and seconded by Fran Hunt to approve the agenda as presented. The motion received unanimous approval.

A motion was made by Rhonda Perkins and seconded by Jimmy Adkins to approve the minutes of the May 10, 2024, meeting of the College Board as presented. The motion received unanimous approval.

Remarks by Chair: Mrs. Marcia Gilliam thanked everyone for attending and welcomed Dave Martel, UVA Vice President of Marketing and Marvin Gilliam, newly appointed UVA Board of Visitors member. She congratulated Chancellor Donna Henry for once again being named to the Virginia Business Women in Leadership Award in the July issue; and stated how wonderful it is that she has been recognized for her leadership and accomplishments. The Dental Remote Area Medical Clinic was held once again at the David J. Prior Convocation Center on July 19 & 20. The clinic treated 612 patients and provided over 3,800 procedures. It is no surprise that board member Rhonda Perkins was recognized in the August Business Journal as one of the 2024 Health Care Heros for her volunteer work at the Johnston Memorial Hospital Cancer Center. Since 2016, Rhonda has given over 2,000 hours of volunteer time. Congratulations to Rhonda! UVA Wise student, Kert Gibson was featured in the Bristol Herald Courier for his diversified college experience. He will graduate in December with a Bachelor of Science degree in biochemistry and with a minor in exercise studies with a 3.9 GPA. He is currently studying abroad for a semester in Canterbury, England with plans to become an orthopedic surgeon. Kert is not the typical pre-med student—he also was a member of the UVA Wise football team for four seasons. He indicated that it was tough sometimes, but it was worth it and he would not change a thing. Chancellor Henry added that she plans to join the Canterbury Study Abroad class for a week in November.

Remarks by Vice Chair: Mr. Lewey Lee shared some interesting history of the College from approximately seventy years ago. One of the inaugural faculty members was Theodore Gibson, the first professor of mathematics at the College who served until the 60's. Marvin Gilliam's mother, Betty Gilliam, a professor of art, was commissioned to paint a portrait of Theodore Gibson. The rendering is excellent and can be seen in Bowers Sturgill Hall on the second floor. Professor Gibson was also the first professor emeritus, operated the first weather station at the College and coauthored the school song, Dogwood and Rhododendron in 1965.

Remarks by Alumni Association Board Member: Mr. Jimmy Adkins reported that the Office of Advancement and Alumni Engagement, especially Corey Sanchez and Katie Pridemore, continue doing an amazing job of outreach, support and fundraising. In your board packet, you will find a list of upcoming/future Alumni and Friends events being held this academic year throughout the Commonwealth of Virginia, North Carolina and Tennessee. He encouraged everyone to attend these events and enjoy the fantastic fellowship. You will also find information in the board packet regarding the naming opportunities for seating in the David J. Prior Convocation Center that will provide donors an opportunity to support the College while memorializing and honoring family and friends. The Alumni Association Board of Directors Annual Retreat was held on Saturday, June 8 at which time Luke Layne handed the gavel over to the new President, Bill Stokes. The fall meeting is scheduled for Tuesday, September 11. Homecoming activities are planned for the week of October 7. Go CAVS Go!

Remarks by Student Member Layne Bush: Chair Gilliam welcomed new student board member and shared that Ms. Layne Bush is a junior majoring in chemistry with minors in biology and Appalachian Studies, a member of the Student Government Association as a junior senator, founding member and treasurer of the American Chemical Society UVA Wise chapter, student representative on the UVA Wise Alumni Board, member of the Future Professionals Club, a Peake Honor's Scholar, Jeroleen and Lee Elam Scholar and a Carl W. Smith Chancellor's Scholar. Layne extended her gratitude to the College Board for entrusting her with representing her fellow CAVS this school year. She considered it an honor to serve as the student member of the College Board. She began by highlighting what her fellow Highland Cavaliers have been involved in during the summer. Eleven UVA Wise students, including Layne and former student board members Charlotte Mabry and Logan Smith ventured with Dr. Heather Evans to Yugoslavia, Bosnia, Ireland, Montenegro, Croatia, and Cosgrovia. This trip was made possible by funding from the College and is greatly appreciated. The students learned about the history of Yugoslavia wars and spoke with members of the U.S. Embassy regarding foreign service opportunities. The trip was priceless and truly allowed her and her classmates an experience in new ways of learning and truly experience and understand experiential learning by broadening cultural awareness. This trip would not have been possible without UVA Wise funding and support. Student Abigail Edwards participated in summer research regarding evaluating the impacts of aromaticity in dye uptake of copper-based metal-organic frameworks at the Fall Chemical Conference in Denver, Colorado. This experience helped Abigail build confidence not only in the classroom but also outside the classroom. Move-in weekend for new and returning students was held on August 16 and August 17 with many fun and exciting events being held. Just to name a few: tie dye shirts, music, karaoke, wallyball, paint party, student activities fair, big screen movies on the Lawn by the Lake, DJ Bingo and multiple social hour mixers. Layne extended her appreciation to Mikaela Logan and Olivia Mullins in the Office of Student Engagement for their hard work in planning Fall Expedition and Welcome Week. The student member of the board is now an official member of the SGA Executive Board and shares an office with the SGA President William Rudeseal. Some of Layne's goals for the upcoming school year include activities to better connect with students to learn more about their concerns and to help with resolutions. A directory has been placed in the Slemp Student Center elevator to show the shared office location for the student member of the board and SGA President. She plans to collaborate with UVA student member of the Board of Visitors with a visit in the spring. Layne thanked everyone for their dedication to the success of the students at UVA Wise.

ACTION ITEMS

<u>UVA Wise Master of Science in Nursing – Family Nurse Practitioner</u>: The Nursing Department Chair and Professor, Nancy Haugen and Associate Professor of FNP, Chrissy Mullins reported on the progress and requirements toward implementation of this program. The purpose of the program is to increase primary care providers in the region and increase advanced education opportunities for nurses in southwest Virginia. The UVA Wise Master of Science in nursing – Family Nurse Practitioner degree program announcement has been prepared and must be approved by the State Council of Higher Education in Virginia (SCHEV). Attached as Appendix A.

A motion was made by Marvin Gilliam and seconded by Karen Mullins to approve the Master of Science in Nursing – Family Nurse Practitioner degree program and support the program announcement, including the workforce needs and duplication analyses provided to SCHEV, as presented in Appendix A. The motion received unanimous approval.

Chancellor Donna Henry introduced the College's new Provost and Vice Chancellor for Academic Affairs, Gary Johnson. He officially started June 24, 2024, working with senior leadership and academic staff. He is a lifelong proponent of the liberal arts and has spent his academic career supporting institutions committed to providing an education founded on this ideal and helping students realize the benefits as well. Provost Johnson has an undergraduate degree in Comparative Literature from the University of Virginia and a Ph.D., also in Comparative Literature, from the University of North Carolina—Chapel Hill. Most recently he served as Provost at Lenoir-Rhyne University in Hickory, NC and also served as the Dean of the College of Liberal Arts and as a tenured faculty member in the English department at the University of Findlay (OH).

CLOSED SESSION

As required by the Code of Virginia Section 2.2-3711 A (9) a motion was made by Rhonda Perkins and seconded by Jimmy Adkins to convene in closed session for the purpose of discussing a proposed gift to the College and related naming opportunity.

A motion was made by Leton Harding and seconded by Fran Hunt to reconvene in open session. The motion received unanimous approval. As required by the Code of Virginia Section 2.2-3711 (D), a roll call vote was taken in open session noting only public business matters lawfully exempted from open meeting requirements and only public business as identified in the motion by which the closed session was convened were heard, discussed, or considered in the meeting of the public body.

RECONVENED IN SESSION

ACTION ITEM

<u>Proposed Gift and Naming Opportunity</u>: A motion was made by Leton Harding and seconded by Brian Blanton that the College Board authorize the Executive Committee of the College Board to approve the Naming of College facilities in exchange for a transformational gift to the University of Virginia's College at Wise once the gift agreements are fully executed. The motion received unanimous approval.

Report Items:

<u>College Budget:</u> Chancellor Donna Henry and Joe Kiser reported on the impact of the recently completed and approved revised General Assembly 2024-2025 operating budget. The budget approved in May by the College Board that included the \$1M in operational funding was approved by the General Assembly. The College committed to growing programs with the additional funds. Compared to other institutions in Virginia, UVA Wise is outpacing all other public institutions in appropriations from the Commonwealth with the exception of one.

Innovate2EleVAte (iPad Initiative): Sabrina Oureshi, Associate Provost of Academic Programs and Curriculum provided an update regarding the College's status for a second time as an Apple Distinguished School Recognition for 2024-2027 as well as innovative ways faculty and students are utilizing iPad technology. This program since its implementation in 2019 continues to demonstrate the College's commitment to expanding digital learning opportunities for UVA Wise students, faculty, and staff. Innovative examples of this technology was showcased by the following professors and staff: Molly Perry, Instructional Designer shared iPad technology through the use of the suite of resources, text book workbook and eportfolios to help students navigate their college journey from convocation to graduation. Rachel Clay-Keohane and Wendy Martin, Instructors in Math shared how students are using iPads as a personal organizer, academic tutor and personal research assistant. They demonstrated how workbooks are utilized with iPads in Calculus class in the classroom and outside the classroom, including Dollywood excursions by collecting data to determine cost analysis and wait time versus enjoyment, basketball free throws, the temperature of coffee effects, ADA ramps, and educators in K-12 classrooms. Ben Mays, Department of Visual & Performing Arts Chair teaches a haunted houses course utilizing iPad technology to create, design and build haunted houses. Donnie Sorah, Associate Professor of Music and Apple Instructor shared how open educational resources can be utilized with iPads by having his music appreciation student's create their own text books thus providing quality educational resources for free.

Enrollment Management: Jeff Baylor, Vice Chancellor for Enrollment Management presented the current recruitment funnel/pipeline data that shows applications have increased over 500% compared to the five year average. This shows how the College is penetrating the market and how students are moving through the recruitment pipeline. This confirmed data is very positive. Admissions moved from SalesForce software to Slate CRM software due to cost savings. The CAV Module for orientation tracking measurements are also looking good for confirmed students. The Year in Wise students applications are above 100. Current 2024-2025 plans and priorities include increasing freshman by 2% and transfers by 1%. TJ, artificial intelligence recruiter, will be demonstrated at the next meeting.

<u>Chancellor's Report:</u> Chancellor Henry reviewed current enrollment data that shows degree-seeking enrollment grew over 250 students from 2023 to 2024, new first-time students grew by 26 which is a big jump compared to 2021 and 2022. Current Year in Wise number is 107 and fall undergraduate enrollment headcount number is up to 2,007. There was a bump in the number of international students thanks to some dedicated recruiting efforts. Numbers will be confirmed at the census date of September 14.

Student Affairs: Tabitha Smith, Interim Vice Chancellor for Student Affairs shared details regarding office location change, personnel updates, budget reallocations and Student Government Association support. Julie Scott assumed the role of Interim Director of Housing in mid-May and hit the ground running with her team. The Housing Report in May was 534 and is currently at 632 which

is a significant jump from last year. Housing capacity is 601 so creative methods have been used to increase housing capacity to 632. This includes doubling up Residence Assistants (RA's) from singles, utilizing lounge space, staff apartments and houses. New this year was move in day being held on Friday instead of Saturday. Leadership training was held for Expedition Leaders and Mentor Leaders. Over 252 students participated in offered excursions off campus and on campus. Out of 515 new students, 447 participated in Expedition, which is a great participation number. Additional move-in week activities included Slemp after hours with karaoke, silent disco and a movie on the lawn.

Student Housing Update: Joe Kiser reviewed future plans to accommodate larger numbers of students living on campus. Some strategies include modular units and a potential partnership with a company that is planning to build housing in Wise County near the Justice Center that would include 32 beds (duplex units) that the College could manage. This is an exciting opportunity with graduate programs coming on board and increased enrollment. Housing will be a large part of the upcoming master planning. Tabitha Smith noted that students have requested kitchens in residence halls and will be beneficial to international students with dietary needs.

<u>Chancellor's Report</u>: Chancellor Henry pointed out the new board packet item updates of Little CAVS Early Learning Center. Little CAVS is currently full with a wait list. Another new report included the CTE report that shows numbers are growing. In Athletics, a new Men's and Women's full-time Tennis Coach Alex Hunt will be on board in a couple of weeks. Chancellor Henry reviewed photos of events that included the RA dinner at Lila Vicars Smith House, move-in day helpers and the incoming class of 2028. President Ryan attended Fall Convocation and met with the new 34 Smith Scholars. Two new members of the Board of Visitors also attended, Dan Brody from Charlottesville and Michael Kennedy, faculty representative.

The curriculum for the proposed Master of Science in Nursing – Family Nurse Practitioner track is designed to prepare students for collaborative and independent primary care advanced nursing practice. The curriculum is designed around AACNs (2021) *The Essentials: Core Competencies for Professional Nursing Education* focusing on the Advanced-Level Nursing Education and the level 2 sub-competencies that build on the entry-to-practice level 1 sub-competencies. This program will prepare graduates for practice and certification in an advanced nursing practice specialty, specifically the primary care Family Nurse Practitioner. The program focuses on specialty knowledge, attitudes, and skills required for advanced nursing practice roles within the healthcare system.

The curriculum includes clinical practice that allows students to develop the knowledge attitudes, and skills required for advanced nursing practice. Students will complete 750 hours of clinical with a qualified preceptor. Students will be required to meet the Level 2 subcompetencies as stated in the AACN (2021) *The Essentials: Core Competencies for Professional Nursing Education.*

The proposed Master of Science in Nursing requires successful completion of 44 credit hours.
This is a non-thesis program with a concentration in Family Nurse Practitioner. Students may enroll as a full-time or part-time student. The full-time option may be completed in 5 semesters of full-time study and the part-time option can be completed in 7 consecutive semesters. The program will be offered online with the exception of two hybrid classes. Graduates of the program will be eligible to take the Family Nurse Practitioner

certification exam administered by AANPBC or ANCC.

At the completion of the program, graduate will be able to:

- Synthesize, translate, apply, and disseminate evidence in health and nursing science to improve the health of a diverse patient population and advance nursing science.

- Inform the design and implementation of system level initiatives aimed at improving health equity and the quality and safety of healthcare delivery using health information technology.

- Implement advanced nursing practice interventions to manage person and family centered care within a framework of professional accountability, collaborative disposition and comportment that reflects nursing's characteristics and values.
- Utilize a systematic decision-making process to provide person-centered care and clinical management that focuses on individuals and families; integrating evidence-based practice to improve health outcomes, health promotion, and disease prevention.
- Participate in activities and self-reflection that fosters personal health, resilience and wellbeing and foster ongoing professional practice and clinical expertise expected of the Advanced Practice Nurse.

Lack of Equity in Advanced Nursing Education

Access to the Virginia Higher Education System is based on location. There are no public Graduate Nursing Education programs in Southwest Virginia. Radford University is the closest state school that offers an MSN with a Nurse Practitioner Track. This is over 100 for most residents of southwest Virginia. There are only 3 institutions in western Virginia, Bluefield College, Emory & Henry College, and UVA Wise, that offer Nursing degrees and of those only Bluefield College offers an MSN-Family Nurse Practitioner Program.

UVA WISE Commitment to the Region

The mission of the college UVA Wise partners with organizations to develop strategies for health and wellness, economic growth and job opportunities. The lack of a public graduate nursing program does not allow us to fulfill our mission in helping to improve the economic growth and population health in our area of the Appalachian Highlands.

Student Demand

In a survey conducted in January and February 2024 by the UVA Wise Nursing Marketing Team, 57% of the 61 respondents indicated they are extremely interested or very interested in enrolling in an MSN-FNP program at UVA Wise.

RECONVENED IN SESSION

Remarks by Chair: Mrs. Marcia Gilliam began the meeting by thanking everyone for attending and welcomed Amanda Pillion, Chair of the UVA Wise Committee, Marvin Gilliam, of the Board of Visitors and Dave Martel, Vice President for Communications and Chief Marketing Officer.

The Annual Benefactors Celebration was held last Saturday. Mike and Debbie Quillen were honored with the UVA Wise Gift of Distinction, Andy and Delores Still received the Benefactors of the Year award and Winston Ely was named UVA Wise Volunteer of the Year. Donna Henry announced the College received a historic gift of 11.2 million from The Bill Gatton Foundation. It was a magical night and kudos to everyone that played a big part in this accomplishment. A Day in STEM-H was held recently at the David J. Prior Convocation Center with over 500 6th graders and

over 150 UVA Wise staff, faculty and students. The middle school students were from Lee, Scott and Wise County. The workshops lead by professionals from the College and outside businesses included hands-on activities such as suturing a banana, strawberry DNA extraction, touching a human brain and so many more. The big take away for the students is that if they can see it, they can be it. The College was named as an Apple School of Distinction for the second time for 2024—2027. Everyone was encouraged to review the upcoming events listed on page 30 of the College board packet and to attend the upcoming open house for the Little CAVS Learning Center on November 26th. Remarks by Vice Chair: Mr. Lewey Lee shared some interesting College history regarding Samuel Robert Crockett. He was born in Wythe County in 1909, attended Roanoke College and taught 36 students in eight different grades in Wythe County in a one room school, served as a principal in several high schools and was a UVA Extension Director for SWVA. Sam Crockett was instrumental in the establishment of Clinch Valley College through the encouragement of some local women from Wise while staying at The Inn at Wise. UVA President Colgate Darden said no one worked harder than Sam Crockett in pulling together what was needed to establish the College. Crockett Hall on campus was named after Mr. Crockett and he was the first Director of Clinch Valley College before a Chancellor was hired. Roanoke College named him one of the Most Distinguished Alumni in the first 150 years. Chancellor Henry shared that the College gives an annual Crockett Award in his honor.

Remarks by Alumni Association Board Member: Mr. Jimmy Adkins shared that Valerie Lawson, Office of Advancement and her Alumni team continue to do an amazing job outreach and fundraising. He hears from many Highland Cavaliers from outside the area about how excited they are to attend the upcoming Alumni and Friends events. The 30th Annual Spring Swing Golf Tournament will be held on April 11, 2025, and the 28th Cavalier Celebration will be held on May 17 at the Lonesome Pine Country Club. Tickets are \$125 each and include dinner and dancing for two and a chance to win money. The Alumni Board had its first meeting of the term on September 11 and the next meeting is scheduled for November 12. Homecoming events were held on October 12 that included the Alumni picnic, the Athletic Hall of Fame induction and Golden Cavalier Brunch honoring the class of 1975. The SWVA Bowl is tomorrow, November 9. Powell Valley National Bank sponsored the SWVA Bowl and provided the trophy on display. A bus is scheduled to take students to the game at Emory. GO CAVS GO!

Remarks by Student Member Layne Bush: Thank you for the opportunity to speak on behalf of fellow students. It has been an exciting semester thus far with an increase in student involvement, and opportunity on campus and in the community. Layne highlighted some student initiatives that occurred on campus in the aftermath of the hurricane. Even though campus was not affected by the storm and most of the students were at home safe with their families over fall break, many were without power, cell service or difficulty traveling back to campus after break. The leadership and staff provided resources needed to support all students. For example, meals in the dining hall were free even if you did not have a meal plan, professors worked with students who needed extra time to travel back to campus and donations were collected for those most in need. It was truly heartwarming to see our small campus come together to support the region that we all know and love. On behalf of the student body, Layne extended sincere thanks to Chancellor Henry, Tabitha Smith, Mikaela Logan, Julie Scott and all leadership for the student support and safety provided. Homecoming activities included a lip sync battle, chariot race and Casino Night. She commended Chancellor Henry for participating in the lip sync battle with a video. SGA sponsored a

sweatpants giveaway during the game with all distributed within the first hour. Over 400 students participated in these events with a great amount of engagement. Thanks to Mikaela Logan, Office of Student Engagement and Tabitha Smith for making homecoming week a success and Chancellor Henry for her support and participation. The SGA Election & Policy committee along with Professor Heather Evans worked diligently to provide campus with educational resources, voter registration assistance including how to cast a vote, transportation to polls and absentee ballots for out of state students. Over 30 students were registered to vote. SGA has chartered several new clubs including Operation Smile, Cavalier Wrestling Club, Pickleball Club, Strength Club, Turning Point, Nutritional Awareness Club and Feral Cat Colony Control Group. SGA brought back the once popular Scary on McCrary for Halloween. Over 300 students participated in a costume contest, pumpkin pie eating contest, trunk or treat and a haunted house hosted by Theatre Department. The SGA has used 32.1% of the total budget equating to \$19,496.75 of the budget has been used thus far. Funding allocations included shipping costs for Operation Christmas Child Drive, Black History Month programs and celebrations and expenses for student conference attendance. Future initiatives to be funded are Lighting of Crockett Hall in the fall, and in the spring, Cavapalooza, Day of Service and Student Leadership Banquet. SGA has made leaps and bounds in increasing social medial presence. Layne reached out to the Board of Visitors Student Representative Lisa Koplenik to let her know that she looks forward to meeting her and discussing how to strengthen the connection between Wise and Charlottesville, especially the Year in Wise program. The student performers at the Benefactor's Celebration were commended for their amazing performance. Stingers down!

ACTION ITEMS

<u>UVA Wise 2025-2026 Graduate Tuition and Required Fees</u>: The University of Virginia's Board of Visitors sets undergraduate, graduate, professional, and special program tuition and fees for the Academic Division and for The University of Virginia's College at Wise. The enabling resolution covers the 2025-26 graduate tuition and required fees for The University of Virginia's College at Wise. The University of Virginia's College at Wise is presenting no increase to graduate tuition and required fee rates for the 2025-26 academic year. It is the College's desire to keep tuition and fees as low as possible for our students. A motion was made by Leton Harding and seconded by Fran Hunt to authorize no increase in graduate tuition and required fees as presented. The motion received unanimous approval.

<u>UVA Wise 2025-2026 Student Housing Rental Rates</u>: To maintain and effectively operate the college's residence halls, revenue must reflect the cost of operation. The Commonwealth of Virginia does not provide operational funding for residence halls. To continue providing housing opportunities that meet the needs and expectations of the student body, and remain competitive in the current market, the recommendation is that we increase the current rates for residential students by 2% over the current year effective July 1, 2025. A motion was made by Fran Hunt and seconded by Jimmy Adkins to approve resolution as presented. The motion received unanimous approval.

<u>UVA Wise 2025-2026 Student Meal Plan</u>: To maintain and effectively operate the College's dining services, revenue must reflect its cost of operation. The Commonwealth of Virginia does not provide funding for operational meal services. Staff members have listened to students on their desires for meal plan options and their views on food service on campus. The College has continued to address student concerns and requests which include modifying meal plan structures, hours of operation, and premium service options. The College has continued to add options to address the needs of the students and those who look to the College for dining options. The students are provided with the option to obtain an unlimited dining plan which provides for all day unlimited food and

beverage service in the Smith Dining Commons as well as 50 meal swipes for retail locations. The Cavalier Red Plan, available to upperclassmen, offers 175 meal that can be used in any dining location, plus \$50 bonus dollars. The Consumer Price Index (CPI) for Food Away From Home in the South through August 2024 was 3.6 percent, which is a component of this proposal. Working with Chartwells, the College has recommended maintaining the current board plan. The rate for these plans along with the block meal plans: 25, 50 and 80 for non-residential users are recommended to increase by 4.2 percent over the current year due to the rising food costs and continued compensation increases for employees. A motion was made by George Hunnicutt, Jr. and seconded by Phillip Blevins to approve resolution as presented. The motion received unanimous approval.

UVA Wise 2025-2026 Conference, Event & Wellness Rates: UVA Wise has a well-established, year-round Conferences & Events (C&E) program. C&E provides on campus event opportunities to various groups during the academic year and in the summer months. C&E utilizes the College's academic classrooms, indoor and outdoor recreational facilities, conferences, and meeting spaces, as well as residential facilities (during summer months) to accommodate campus each year. Conferencing and events programing is proposed to remain at the same level as last year, with the exception of a \$1 increase to the lodging rate. Summer programming, besides increasing utilization of spaces, also provides a recruitment and marketing tool for the College. Given this, the Administration is recommending that all other rates for 2025-26 remain at those approved by the Board for the current year with the exception of meals. Rates have been added for Greear Gymnasium as we had not previously incorporated separate rates for this space, and Greear Pool revised their rates to add pricing by age. Since its opening, the Prior Center has not increased its rates while growing its staff and student workers to manage the facility. This request proposes increases to the rental of the floor space and reducing the rental of the concourse area. The increase is needed to cover the increasing costs of goods and services, including the increase in employment wages. A motion was made by Jimmy Adkins and seconded by Fran Hunt to approve resolution as presented. The motion received unanimous approval.

<u>UVA Wise 2025-2026 Parking Fees and Fines</u>: The Commonwealth of Virginia does not provide four-year institutions with funding for the establishment and maintenance of parking facilities on campus. The administration is not proposing an increase in parking fees and fines. A motion was made by Kathy Curtis and seconded by Rhonda Perkins to approve the resolution as presented. The motion received unanimous approval.

Report Items:

Joint Legislative Audit and Review Commission (JLARC) Reports: Chancellor Henry and Vice Chancellor Joe Kiser reviewed pertinent details regarding recent JLARC reports regarding enrollment at Virginia universities that included UVA Wise. UVA Wise was listed as a moderate risk level in the institutional appeal risk factor of pricing power and having a decrease in tuition revenue per student. It is important to note that the reports were ordered in 2023 and data used was from 2014-2023. This data did not include the Colleges two most recent years of enrollment growth and the general funding investment in new academic programs, creation of Little CAVS Early Learning Center and increased student support services that included the enrollment and retention strategies that helped grow the College. Vice Chancellor Kiser highlighted the work done at UVA Wise to gain efficiencies and have a positive impact on students. This included staffing efficiencies, UVA/UVA Wise

collaborations, updated Liberal Arts Core, lower-published price than the national average and net price paid by UVA Wise students compared to published cost of attendance that included merit-based aid and scholarships that lowered actual amounts paid or borrowed.

Enrollment Update: Chancellor Henry provided enrollment numbers that showed an increase two years in a row and the demographic breakdown of enrollment by state, Virginia counties, international students, gender, athletes, students receiving Pell, distance from home and dual undergraduate and graduate students by Virginia counties. Vice Chancellor Baylor provided 2025 spring recruitment numbers that reflect an increase of 50% from previous spring numbers in both Freshman and Transfer confirmed numbers. The 2025 fall recruitment numbers are a little behind due to transition to new CRM system and currently playing catchup. The SLATE JRM applications are ahead of last year and yields higher than other categories. The NICHE system generates volume but typically has the lowest yield. The SLATE system is working on integration to Jenzabar system and will allow confirmed students to go to the orientation/housing module. Federal Pell grants are up \$1.6M, federal student loans are down 19 students and parent plus loans are down by 18. Vice Chancellor Baylor demonstrated the new Artificial Intelligence (AI) recruiter "TJ" through a phone call and by asking multiple questions regarding UVA Wise. The AI recruiter can be accessed across multiple communication channels like phone, email, mail, and SMS.

The Bill Gatton Foundation Gift: Vice Chancellor Lawson recognized her Advancement team and the Marketing team for their dedicated work in Advancement and the Campaign. Vice Chancellor Lawson also recognized Valeri Colyer, Rhonda Perkins, Chancellor Henry, Sarah Mullins and Lewey Lee for their contributions in receiving this gift. The \$11.2 million gift from The Bill Gatton Foundation will be used as following: \$1M greatest needs fund, the naming of The Bill Gatton Department of Nursing, the Bill Gatton Technology and Data Analytics Hall and the naming of the Bill Gatton Department of Technology Management and Data Analytics program, the creation of the Bill Gatton Scholars Program which includes academic, athletic and the Bill Gatton Technology & Data Analytics scholarships, the Rachel Clay-Keohane Mathematics Fund and The Bill Gatton Field. A video of the official gift announcement and celebration of this historic gift was shown. The Campaign total is now over the \$100 million goal. Dave Martel and Mark Luellen from UVA have been very instrumental in achieving this goal. As of today, annual giving is \$17,898,906. Vice Chancellor Lawson also recognized Rosa Bott for her contributions and the quality work she provides with sound and technology.

Chancellor's Report: Chancellor Henry reported that Paul Rollins, Chief of Staff, had taken another position. Lt. Governor Winsome Earle-Sears visited UVA Wise, toured campus and met with students on the same day that Ian Baucom, UVA Provost and several UVA Deans visited the College. UVA Wise Provost Johnson coordinated the UVA visit with sessions with UVA Wise Deans. As mentioned earlier, the College received the Apple School of Distinction for a second time. Board member Karen Mullins commented on how impressive the Apple work was in the classrooms and as showcased by the students at the Apple celebration. Chancellor Henry shared photos of some of the Fall Student Life activities such as Expedition activities, goat yoga that had over 100 students participating, Scary on McCrary that included a haunted house, squish buddy building, pumpkin pie eating contest and a costume contest, and the Majors Fair that is part of Taking Care of Business Day that gives students the opportunity to meet with Advisors, Registrar's office and the financial aid office. Chancellor Henry reminded everyone to take the brochures detailing how to purchase a

named seat at the David J. Prior Convocation Center that gives you the opportunity to honor or memorialize you loves ones while making a difference toward the College's greatest needs.

There being no additional business or comments the meeting adjourned at 12:20 p.m.
